This show is approved by and conducted under the rules of the American Miniature Horse Registry (AMHR) or American Shetland Pony Club (ASPC). All horses entered in this show must be officially registered with AMHR/ASPC. All Youth/Amateur exhibitors must provide their current (2019) Youth/Amateur number in the designated space on the front of the entry form. No youth under 13 years of age may show a stallion.

Show Management reserves the right to settle and determine questions, differences, and disputes arising out of or connected with or incidental to this show within the boundaries of AMHR's Show Rules.

NO LOGOS, NAMES OR OTHER IDENTIFICATION OF PERSONS OR FARMS WILL BE ALLOWED ON ANY EXHIBITOR, HORSE, OR VEHICLE IN THE ARENA. No clients or member of a judge's family or business clients of a judge may compete as an exhibitor in a show unless the relationship is terminated at least 90 days prior to the show. Owners, Lessees and Exhibitors agree OMHCI, McClain Co. Expo. Center and AMHR/ASPC will NOT be responsible for any theft, injury, or accidents in conjunction with this show. Cruelty, abuse or inhumane treatment of any horse in the show ring, barn, stalls or on the grounds is strictly prohibited. The use of stimulants or depressants or any drug affecting the showing of a horse is forbidden.

**THE FOLLOWING LEGIBLE PAPERWORK MUST BE SUBMITTED BY MAIL WITH THE ENTRY FORMS:**

1. Copy of each horse's AMHR or ASPC registration papers (front and back); be sure papers are stamped with AMHR stamp, for leased horse(s).
2. Copy of current (2020) AMHR Youth\*/Amateur Card. \*Youth do not need a card to exhibit, but placings, points and awards will not count.
3. Check for monies due. **MAKE CHECKS PAYABLE TO: OMHCI** Trainers please include your contact information.

**NOTE: Entries that are received without these items will not be eligible for pre-assigned stalls. Post-entries will be accepted up to 30 minutes before the beginning of the show on Saturday, June 27 and Sunday, June 28. Entries postmarked after June 13, 2020, will be charged at the late fee rate noted below and they will not be eligible for flat fee rates.**

**All horses will be required to have a Negative Coggins within 12 months and health certificate within 30 days.**

Do NOT send health papers and coggins in with your entries; but they MUST be presented when you check in at the show.

**Refund Policy:** A full refund will be given if entries are cancelled in writing to the show manager before the closing date of pre-entries. If entries are cancelled in writing and accompanied by a veterinarian's or doctor's certificate of inability to show after the closing date of pre-entries, but before the official start of the show, all fees other than the stall, shavings and office fees will be refunded. After the official start of the show, there will be no refunds. Substitution of a horse will be accepted with no late fee.
