- If the horse is leased, a copy of the lease with ABRA stamp for the leased horse(s)
- Copy of current (2025) ABRA Membership Card

- ❖ One entry per horse
- ❖ Post-entries will be accepted up to 30 minutes before the beginning of the show on Sunday, May 18.
- ❖ **Entries postmarked after May 1, 2025, will be charged at the late fee rate**
- ❖ All horses must have Negative Coggins within 12 months and a health certificate within 30 days.
- ❖ Do NOT send health papers and Coggins in with your entries, but they MUST be presented when you check in at the show.

No clients or members of a judge's family or business clients of a judge may compete as an exhibitor in a show unless the relationship is terminated at least 90 days before the show. Owners, Lessees, and Exhibitors agree with OMHCI, Heart of Oklahoma Expo Center and ABRA will NOT be responsible for any theft, injury, or accidents in conjunction with this show. Cruelty, abuse, or inhumane treatment of any horse in the show ring, barn, stalls, or on the grounds is strictly prohibited. The use of stimulants, depressants, or any drug affecting the showing of a horse is forbidden.
